Sam Waters: “We were spending too much time preparing standard documents and automation was the only solution. Our paralegals were spending 4 to 10 minutes preparing each standard pleading for attorney review. The majority of the standard pleadings contained 7 to 40 variables. The paralegals found

themselves typing the same variables over and over again. After comparing the costs of installing and configuring Invantive Composition with the costs of the least expensive employee, we found that the investment would pay itself back at least every three years.”

“The law in the United States is ever evolving and changing; we expect the number of pleadings to increase and the law to become more complex. Using templates to create pleadings will allow the paralegals to prepare documents more easily, which means less time is needed for preparation. The Invantive Composition product takes legal cases from our case management system IBM ECM and creates a ready-to-review pleading, cutting our preparation time with 70%.”

No IT-skills required

“We were looking for a product that met two main requirements: the automation had to incorporate Microsoft Word and templates needed to be created by non-IT trained paralegals. We considered Oracle’s Documaker - a fine product -

Integrated into Word

“Invantive’s software met the criteria GuideOne was searching for, which included that the pleading had to be completed or prefilled in either Microsoft Word or Word Perfect format. The reason for that is that about a third of the pleadings that are prepared must be presented to a court for judicial review.

“Invantive Composition was just what we needed. Based on a Proof of Concept, it soon became clear that Invantive was able to help GuideOne achieve its goals.”

Accordingly, the judge may make edits or changes before the

document is finalized. Invantive Composition met that requirement. We also wanted a product that could be modeled by the paralegals. Our IT department has increasing demands upon its resources and we knew they did not have the resources to model our legal templates. Because of that, we chose Invantive.”

Increased productivity

“We found that Invantive BV was particularly interested in making sure GuideOne was receiving value for its money spent. Invantive was receptive to additions which improved both the use of the product and the final outcome of the project. Invantive Composition wards off our need to add staff despite growth of the yearly premium. We expect that we will be able to add two more lawyers before we have to add corresponding supporting staff.”


